# MINUTES.

OCTOBER 8, 1886.

## REPORT ON DOCUMENTS.

Your committee have had under consideration the documents submitted and beg leave to report that—

The church at Hayneville asks our aid in building a house of worship; the church reports progress.

The church at Lowndesboro has been resuscitated and asks help to procure and keep up preaching there. They have no house of worship and inquire if we can help them to build.

The church at Hickory Grove recommends the continuation of Bro. Plaster as evangelist. We find that Bro. C. C. Lloyd of Antioch church has been licensed to preach; that Bro. G. W. Webb of Damascus church has been ordained to preach, and that Bro. R. M. Burt of Bethel church has been ordained to preach.

We find that through the labors of our evangelist Good Hope church is represented here, the first time in several years, and asks for any assistance we can give.

Steep Creek and Damascus ask for the Association next year.

Union church reports the ordination of Bro. J. G. Thomas to the office of deacon.

Macedonia asks assistance in procuring regular preaching.

Ebenezer reports the ordination of two deacons.

Rutledge church asks aid to remove debt on their house of worship.

## STATE OF RELIGION IN THE CHURCHES.

Your committee beg leave to report that eighteen (18) churches have sent letters to the Association. Of these, ten churches report an increase of members, and a state of prosperity; of the eight others, some report a good condition, and none report much decline.

We believe, therefore, that we have reason to thank God and take courage as an association. We notice there has been an unusual number of deaths, and are reminded that our Father is calling his children home, and therefore we sorrow not as those who have no hope, for if we believe that Jesus died and rose again, "them also which have fallen asleep in Jesus will God bring with Him." Fourteen deaths are reported.

Number baptized, ninety-six (96.)

We regret the meagre amounts sent up by the churches for missionary purposes and desire to call the attention of the brethren to the grace of our Lord Jesus Christ, who, though He was rich, for our sakes became poor, that we through His poverty might be made rich.

## REPORT ON MISSIONS.

Your Committee beg leave to report that during the past year the Mission Work has been sustained by the churches of our denomination throughout the whole world, and that every known nationality has heard the gospel of Christ from the lips of your own ministers. The churches have been able to do this by co-operation through the agency of the various Boards.

The ministers of the foreign field composed the heathen, and others have been reached and aided by the Board of Foreign Missions of the Southern Baptist Convention at Richmond, Va. Ministers in China, Africa, Italy and Brazil have been greatly blessed and prospered of God. The Board of Home Missions at Atlanta, Ga., have found new fields of enterprise besides maintaining the ground heretofore won, is thus lengthening her cords and strengthening her stakes, and is marching forward under the banner of the captain of our salvation to new victory and a glorious future. The baptisms have been 3,812.

Our State Mission Board is laboring earnestly, by the direction of the churches of the State to preach the gospel of the Son of God to every creature in the State, and if they shall continue to receive the divine approbation in the future as in the past, the blessed gospel of Christ will be in reach of all. The Board has had sixty-five men employed a part and all of their time. During the last year over 600 have been received by experience and baptism, through the labor of these faithful men. The women of Christ, like their sisters of old, have rendered constant and efficient aid to the cause of Christ. Besides these, the State paper, the *Alabama Baptist*, has been of substantial aid, and under the present management, promises increased usefulness.

Our own Associational Board has been intrusted with your evangelical work and we refer to their report for results. Dear brethren of the Association, it seems to your Committee, after a careful investigation of all the facts coming to their knowledge, that God, by His Providence and His Spirit, is leading our denomination in their efforts to preach the gospel to every creature and that we have only been following where he has lead, and that we ought to be willing to be led in the way of His commandment—"To Preach the Gospel to Every Creature;" so that he that believes and is baptized shall be saved.

## REPORT OF EX-BOARD OF ALABAMA ASSOCIATION.

Your Ex-Board beg leave to report that being instructed by the Association that met last year, to employ an evangelist to labor within the bounds of the Association. We held our first meeting October 15th, 1886, at which meeting we decided that there were churches enough in our territory and therefore the labors of the evangelist employed should be with the churches to strengthen and build them up. We also agreed that he should receive \$500.00 for his labors, and \$200.00 more, if collected. Brother Plaster, one of your Board, was chosen evangelist, and was to answer at next meeting. We met again October 15th, 1885. Brother Plaster accepted the appointment and resigned as a member of the Board, and Brother J. A. Stringer was appointed in his place. Brother Plaster was to begin his labors at once, the Board agreeing that he should serve Bethel Church one Sabbath a month till January, 1886.

We met again January 19th, 1886. Brother Plaster was instructed to make one regular appointment at Lowndesboro on the first Sabbath in each month because of the destitution there, the Baptists there pledging material aid.

He was to have no more regular appointments, but to labor where he thought best, among the churches. We made an effort to obtain from the State Board the "David Lee" Colportage Fund and succeeded in part.

We have held three other meetings during the year; one in May, one in August and one to-day, principally to hear reports from evangelists which have been satisfactory to us, and we hope will be to you.

Brother Bruner never having attended our meetings, Brother J. L. Hinson was chosen in his place.

Herewith we give a synopsis of the work of your evangelist

The evangelist cannot report definitely the number of accessions in connection with his labors, the number being reported in the letters from the churches.
